

## Role Definition

**Job Title:** Ecologist

**Reporting to:** Manager on a day to day basis and ultimately to the Senior Partner

The candidate should have an excellent habitat ecology knowledge in a wide geographic/biome areas with an understanding of both habitat and the faunal species that use them.

## Responsibilities

- Work closely with the landscape architects in the team, and directly with the architecture Studios, to develop masterplans and landscape proposals on an international scale which achieve robust net gains for biodiversity. This will mainly be delivered through mainly through:
  - Constant promotion of, and advocacy for, biodiversity within the practice in a diplomatic but effective manner
  - Constant promotion of the mitigation hierarchy when approaching ecological design
  - Undertaking and supporting on ecological research and site context analyses focused on protected sites, habitats and species
  - Undertaking and supporting on deeper research into specific ecological topics or design elements
  - Supporting on (or undertaking) high-level, early-stage ecological impact assessments
  - Production of basic presentation materials and communication of the same
  - Providing on-demand practical advice for biodiversity impact avoidance, mitigation and enhancement within proposals
  - Undertaking metric calculations to quantify ecological impact of proposals, including biodiversity net gain (BNG) natural capital (NC) and other similar assessments (as well as calculations relating to BREEAM, LEED and Green Mark etc. where appropriate)
  - Occasionally assisting with business development and outreach projects regarding ecology
- Contribute, or otherwise assist, as required
- Learn and apply Foster + Partners procedures and standards

## **Qualities and skills required**

- Able to demonstrate ability to undertake the above responsibilities
- Legally able to work in the country in which the position is based
- Degree-level or above qualification in Biology/ Ecology/ Natural Sciences/ Zoology / Botany etc.
- Site-applied ecological advice experience in the development, design or construction industry
- Member of suitable professional institution, or working towards (e.g. CIEEM)
- Conservation or ecological site work experience beneficial
- Good working knowledge of GIS
- Self-motivated and able to take responsibility
- Able to demonstrate initiative and a proactive approach to daily tasks
- Excellent organisational skills
- Able to manage sensitive and sometimes confidential information
- Good interpersonal skills and the ability to work well in a team, assisting and supporting team members, as well as the ability to communicate efficiently and clearly both verbally and in written and graphical form
- Able to build good relationships at all levels, internally and externally
- Resilient to cope with conflicting demands, able to prioritise duties and work effectively under pressure, while remaining calm and professional at all times.
